The BCB is the governing authority for regulating and promoting the game of cricket in Bangladesh. Its Management Office is located at Sher-e-Bangla National Cricket Stadium, Mirpur-2, Dhaka-1216.

The BCB hereby invites full proposal along with quotation from reputed Sports TV Production Companies / Corporate Houses / Firms for delivering international standard sports TV production services for the '**Bangabandhu T20 Cup 2020**' only for one (01) season to be held in November-December 2020. The tournament is a part of the BCB's continuing initiatives for a gradual resumption of normal cricketing activities during the ongoing COVID 19 pandemic.

In this connection, BCB published an EOI (Expression of Interest) advertisement in the national daily newspapers on 2<sup>nd</sup> November, 2020 to invites full proposal along with quotation from reputed Sports TV Production Companies / Corporate Houses / Firms for delivering international standard sports TV production services for the '**Bangabandhu T20 Cup 2020**' only for one (01) season to be held in November-December 2020.

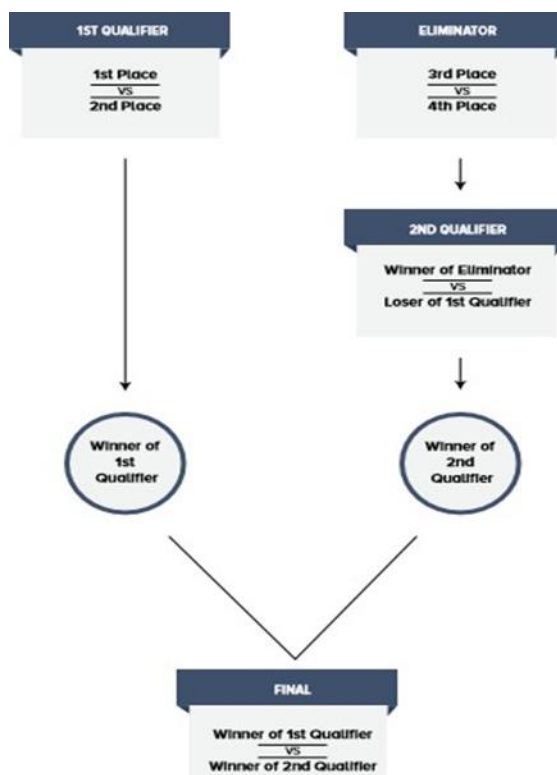
## FORMAT OF THE TOURNAMENT:

The tournament will be played in a double league format followed by play offs and a final.

The first four (04) placed teams in terms of points will feature in the play offs. The first match of the play-offs will be the '**1<sup>st</sup> Qualifier**' between teams placed one (01) and two (02) in the points table. The winner will qualify for the final.

The "**Eliminator**" will be between the 3<sup>rd</sup> and 4<sup>th</sup> finishers in the points table. The winner of Eliminator will play with the losing team of the 1<sup>st</sup> Qualifier in the "**2<sup>nd</sup> Qualifier**" match.

The winning side of the "**2<sup>nd</sup> Qualifier**" qualifies for the final.



**PARTICIPATING TEAMS:**

There are five (05) Participating Teams in the **BANGABANDHU T20 CUP 2020**.

**TENURE OF THE SERVICE:**

The tenure of the Sports TV Production Service shall be for one season only i.e. BANGABANDHU T20 CUP 2020.

**COMMENCEMENT OF TOURNAMENT:**

**BANGABANDHU T20 CUP 2020** is tentatively scheduled to be held in November -December 2020.

**TOTAL MATCH:**

A total of 24 matches will be played throughout the tournament.

**TOTAL PRODUCTION DAY:**

- **League Stage** : 10 days (as per day 02 matches).
- **Play-off Stage** : 03 days (1<sup>st</sup> qualifier and eliminator on same day, 2<sup>nd</sup> qualifier and final match)

Note: there are reserve days allocated for all matches in play-off.

**TOURNAMENTS VENUES (TENTATIVE):**

Matches will be played in 01 (One) International Venue i.e. **Sher-e- Bangla National Cricket Stadium (SBNCS), Dhaka**.

3. TV production firm/company shall provide TV Production Services including Broadcast Equipment as per the detail provided in the above table. TV production firm/company must assure that all Crew and Engineering Services shall be the best as per industry and shall be provided in a professional manner.
4. As part of its services TV production firm/company shall provide various services as per the annexure of the agreement to be executed after necessary evaluation of proposal and awarding the work order.
5. TV production firm/company shall provide commentators and anchors as per BCB's preference. TV production firm/company shall provide a list of the commentators for prior approval of BCB prior to the said cricket Event.
6. TV production firm/company must strictly follow the health & safety guidelines imposed by the BCB/ICC during the ongoing COVID 19 pandemic situation.
