## 1. INTRODUCTION

1.1 BANGLADESH CRICKET BOARD, a national sports organization recognized by National Sports Council, is the governing body for the game of cricket in Bangladesh having its Management Office at Sher-e-Bangla National Cricket Stadium, Mirpur-2, Dhaka-1216 (hereinafter referred to as “BCB”).

The Bangladesh Cricket Board (BCB) invites Expression of Interest (EOI) along with financial offers from the TV Broadcasters or Marketing Agents for acquiring the following Media Rights of

01. New Zealand Teams Tour of Bangladesh 2026

02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only)

03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026

- **Satellite TV (Linear) Rights - Worldwide including Bangladesh**
- **Digital OTT (Over-the-Top) Rights - Worldwide including Bangladesh**

## 2. DEFINITION

2.1 Wherever the following terms are used in this Invitation to EOI Document whether in the singular or plural, or in future or in the past tense, it shall have the meanings ascribed to each of them below, unless otherwise stated explicitly in this document or the context requires otherwise:

2.2 “**Financial Offer /Proposal**” means a financial offer/ proposal for acquiring Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh) of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026 is a formal and legally binding document outlining the specific financial terms and conditions for the acquisition of exclusive global media broadcasting and distribution rights for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026. Financial Proposal/Offer can be submitted as follows:

- i. **Category A: Financial Offer including Production Cost**
- ii. **Category B: Financial Offer excluding Production Cost**

2.3 “**EOI Document**” means the documents required to be submitted in order to place an offer/proposal for Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh) of the 1. - 2.4 **“Participating Team”** shall mean the visiting Team / ICC member country comes to participate in the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026 involving Bangladesh National Cricket Team (Men).
- 2.5 **“Match”** shall mean any ICC recognized ODI under the 1. New Zealand Teams Tour of Bangladesh 2026, (2). Pakistan Teams Tour of Bangladesh 2026 (Test Series only) (03). Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026 involving Bangladesh National Cricket Team (Men) which is officially organized by BCB.
3. **“Worldwide Media Rights”** in this Invitation to EOI Document means Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh) of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026 involving Bangladesh National Cricket Team (Men).

#### 4. GRANT

- 4.1 BCB being the governing body for the game of Cricket within the territory of Bangladesh and being a full member of International Cricket Council (“ICC”) and Asian Cricket Council (“ACC”) has the sole and exclusive authority to organize 03 ODIs Matches under Bilateral Home Series involving Bangladesh National Cricket Team (Men). This EOI Invitation constitutes an invitation to reputed TV Broadcasters or Marketing agencies for Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over- the-Top Rights - Worldwide including Bangladesh) of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026

#### 5. ELIGIBILITY

- 5.1 Companies related to Tobacco, Alcohol (surrogated and non-surrogated), Betting, Online Betting shall not be eligible to participate in the EOI process.
- 5.2 Any person(s) or entities with an existing unresolved dispute (i.e. Financial, Disciplinary and any other) with BCB or ICC on a point of law or fact shall be ineligible to acquire the aforementioned rights or to participate in the EOI Process.
- 5.3 The Broadcaster/ TV Channel must be in operation (on air) for at **least 03 (Three) years**. Marketing agents must have the capability and reasonable experience in marketing international standard cricket events.
- 5.4 The EOI participant must have the legal capacity to enter into a contract. The EOI Participant shall not be insolvent, bankrupt or wound up or its business activities shall not be suspended, and it shall not be subject to legal proceedings for any of the above.
- 5.5 The EOI participant must certify that neither the participating company nor its owner nor any of their affiliates or subsidiaries is engaged in any business related to Tobacco, Alcohol (Surrogated & Non-Surrogated products), betting or gambling in any form, or any defense or national security related business. The participant shall also undertake that it is in no way involved in any activities that may be regarded as unlawful. Any offer of a company which does not fulfill the above specific qualification shall stand automatically rejected.

- 5.6 All prospective participants shall provide the following information/disclosure by way of Statement of Qualification:
- 5.6.1 General description of the type of business in which the EOI participant is currently engaged.
  - 5.6.2 Certification duly signed by the authorized person of the EOI participants that neither the participating company nor the owner/shareholder nor any of their affiliates or subsidiaries is engaged in any business related to Tobacco, Alcohol (Surrogated & Non-Surrogated products), betting or gambling in any form, or any defense or national security related business.
  - 5.6.3 Details of qualification and experience of key persons who the EOI participant intends to nominate to interact with the BCB together with brief CV of such individuals.
  - 5.6.4 Undertaking that the EOI participant is in no way involved in any activities that may be regarded as unlawful.

## **6. FORMATION OF EOI AND FINANCIAL OFFER:**

- 5.1. All the EOI participants shall comply with the following guidelines and pursuant to the same shall submit an EOI as well as a Financial Offer/ Proposal. Each of the EOI participants must provide accurate information in respect of the relevant points listed under “EOI Submission Procedure”.

### **5.1.1. EOI Submission Procedure:**

The EOI along with financial offer (prepared in accordance with the EOI Document) must be submitted at the BCB Management Office at Sher-e-Bangla National Cricket Stadium, Mirpur-2, Dhaka 1216, Bangladesh by **29<sup>th</sup> March, 2026** during office hours (between BST 1000 to BST 1700) and should be in a sealed envelope to be addressed to: **Chief Executive Officer**, Bangladesh Cricket Board. ## 5.1.2 Financial Proposal:

6.1 The Financial Proposal shall expressly state the **NET** Worldwide Media Rights Fee, comprising Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh). Such fee shall be quoted in Bangladeshi Taka and/or United States Dollars, set out in both words and figures. The amount quoted shall be exclusive of Value Added Tax (VAT), income tax, and any other statutory deductions, which shall be applied in accordance with the applicable laws and regulations of the jurisdiction of the respective EOI participant (local or foreign). Financial Proposal/Offer can be submitted as follows:

i. **Category A: Financial Offer including Production Cost**

ii. **Category B: Financial Offer excluding Production Cost**

(a) The following payment structure shall apply in respect of the Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh) Fee, i.e., the Offered Value for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 must be paid by the successful EOI Participant to **BCB in the following manner:**

- i. **1<sup>st</sup> installment- 25%** of the total offered value shall be paid to BCB prior to start the Bangladesh vs New Zealand Series. (i.e. 10<sup>th</sup> of April 2026)
- ii. **2<sup>nd</sup> installment – 25%** of the total offered value shall be paid to BCB prior to start the Bangladesh vs Pakistan Test Series (i.e. 1<sup>st</sup> of May 2026)
- iii. **3<sup>rd</sup> installment – 25%** of the total offered value shall be paid to BCB prior to start the Bangladesh vs Australia Series (i.e. 1<sup>st</sup> of June 2026)
- iv. **4<sup>th</sup> installment- 25%** of the total offered value shall be paid to BCB within 15 days from the completion of Bangladesh vs Australia Series (i.e. 5<sup>th</sup> of July 2026)

The Mode of Payment: Bank transfer at the BCB designated account/ Account Payee Cheque/ Pay order/ DD.

**Currency:** For local company in Bangladeshi Taka; for foreign company in US Dollar.

- (b) Penalty for delay payment: In the event the successful EOI Participant fails to make payments as aforesaid on the stipulated dates the applicant shall be liable to pay penalty interest @ 5 % from the due date of payment till the actual date of payment.
- (c) The successful EOI Participant must submit to BCB a Pay Order or an unconditional and irrevocable Bank Guarantee as per BCB standard format (ANNEXURE - B) for the sum of 75% of the NET offered value accepted by BCB in favor of "Bangladesh Cricket Board" that is valid for a period of at least Four Months within 72 hours from the issuance of Letter of Intent (LOI).
- (d) All payments referred to above will be secured accordingly from the successful EOI Participant and failure to comply will result in disqualification.

**Note :** The Bangladesh Cricket Board (“BCB”) reserves its right, at its sole and absolute discretion, to enter into negotiations with any EOI Participant or any other interested entity(s), after due submissions of all the financial offers submitted by EOI Participant(s) within time stipulated in Clause no. 5.1.1. contained herein, for the purpose of seeking an upward revision of the proposed Worldwide Media Rights fee to a level acceptable to BCB, in the event that the submitted EOI(s) and corresponding financial offer(s) fall below the expected Media Rights value of the said series.

## **7. REQUIREMENTS FOR PREPARATION AND SUBMISSION OF EOI AND FINANCIAL OFFER:**

- 7.1 The EOI Participant shall remain responsible for obtaining all further information necessary or expedient for the purpose of preparing their EOI and Financial Offer / proposal and will be deemed to have done so before submitting EOI. Information may be sought from the date of obtaining the Invitation to EOI Document. No irrelevant query would be entertained and the decision of BCB in this regard shall be final. BCB will not entertain any queries after 5:00 PM on **March 28<sup>th</sup>, 2026.**
- 7.2 Save as specified hereinafter, EOI Document and other supporting papers that may be submitted by the EOI Participant shall and will become the property of BCB and it will not be obliged to return them. However, all information and documents submitted to BCB shall be treated as “strictly confidential” and shall not, unless required in accordance with law / appropriate government authorities / auditors, be disclosed to anyone.
- 7.3 A tentative schedule of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026 annexed hereto as **ANNEXURE - D.** It is however stated that BCB reserves the right to change the annexed schedule at its convenience and BCB shall not be held liable for any such changes. For avoidance of doubt, the tentative schedule of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026, are being provided for information purpose only and the same has no bearing or nexus with the Worldwide Media Rights Fee to be proposed by the EOI Participants. The Worldwide Media Rights are being granted for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026.
- 7.4 Cancellation and Rescheduling of Matches: BCB shall not be liable for any cancellation or rescheduling of any Match during the tenure of this Agreement on account of inclement weather, rain, bad light, or for any other reason whatsoever that is beyond the control of BCB, either without a ball being bowled or after the Match has commenced for a specific period of time. This Worldwide Media Rights is for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh rights fee shall remain unchanged till the end of this contract. In any event, the Worldwide Media Rights Fees payable to the BCB shall not be reduced or deducted for any cancellation or rescheduling or Abandoned of any match.
- 7.5 BCB shall be responsible for the TV production of (i) the New Zealand Team’s Tour of Bangladesh 2026, (ii) the Pakistan Team’s Tour of Bangladesh 2026 (Test Series only), and (iii) the Australia Team’s Tour of Bangladesh 2026, in the event BCB accepts a Financial Offer excluding production

cost (Category B). However, if BCB accepts a Financial Offer inclusive of production cost (Category A), the Media Rights Holder shall be responsible for the TV production and shall comply with the technical specifications set out in the Annexure C subject to BCB's sole discretion.

## 8. AMENDMENT/ADDENDUM

8.1 BCB may, at any time prior to opening of EOI & Financial Offer /Proposal, on its own initiative or for any supervening factors and/or events or in response to an inquiry for further information (including clarification) in writing by a EOI Participant having participated in the invitation to EOI Documents, amend, modify, add or alter the Invitation to EOI Document by issuing an Addendum(s) without having to provide any reason whatsoever.

## 9. RIGHTS OF THE SUCCESSFUL EOI PARTICIPANT

9.1 In consideration of the payment by the Successful EOI Participant of the Worldwide Media Rights Fee, BCB shall grant the Worldwide Media Rights on an exclusive basis subject to, and in accordance with, the terms and conditions of this Invitation to EOI Document and applicable laws of each Territory from time to time in force. For the avoidance of doubt, the Rights shall constitute the right to broadcast or distribute audio-visual, visual coverage of all matches of the Home Series involving Bangladesh National Cricket Team (Men) 2026. set out in ANNEXURE C (i.e. matches and related events by way of Satellite Television, Radio, Digital OTT platform but subject at all times to the Excluded Rights).

9.2 **Worldwide Media Rights includes the following rights:**

9.2.1 **Satellite TV (linear) Rights:** The Rights shall constitute the rights during the Period to broadcast or otherwise distribute audio-visual and visual coverage of the all-Cricket matches of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 by way of Satellite Television only but subject at all times to the Excluded Rights.

**Territory:** Worldwide and Bangladesh.

**Digital OTT (Over-The-Top) Rights:** The Rights shall constitute the rights during the Period to broadcast or otherwise distribute audio-visual and visual coverage of the all Cricket matches of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 by way of internet via OTT (Over-The-Top) platform that may be used for broadcasting in future but subject at all times to the Excluded Rights.

**Territory:** Worldwide and Bangladesh.

9.3 The Successful EOI Participant (Worldwide Media Rights Holder) shall be entitled, subject only to the restrictions expressly set out herein, to market and /or negotiate and/or sell the rights (or any part thereof) to sublicense for exercise in the territories (or any part thereof) during the period. The Successful EOI Participant must intimate to BCB the identity of the proposed sub- licensee and obtain BCBs' written approval at least Three (03) working days prior to appointing it as the sub-licensee. However, BCB reserves the rights to object to and refuse any such sub- license provided such objection is made within three (03) working days of such intimation by the successful

EOI Participant. In the event BCB raises such objection, the Successful EOI Participant undertakes not to appoint the said entity as its sub-licensee. Any grant of sub-license rights shall be done by the sub-license agreement(s) executed by and between the successful applicant and the sub-licensee. The Successful EOI Participant shall be required to provide BCB with copies of all sub-licensing agreement prior to signature of such agreements and the Successful EOI Participant agrees to procure express consent to such disclosure from each Sub-Licensee.

- 9.4 There shall be no exclusivity in awarding Worldwide Media Rights (Satellite TV Broadcasting, and Digital OTT for Global including Bangladesh) in other category rights under BCB. For avoidance of doubt the BCB may take any sponsor including but not limited Title Sponsor, Event Co-Sponsor, In-Stadia Rights Holding Partner, Official NFT Selling Partner Rights, Ticketing Partner, ISP Partner, Hospitality Partner, Telecom Partner, Beverage Partner etc. that may conflict with Media Rights Holder and/or any sponsor of the Successful EOI Participant. Thereafter, under any and all circumstances, the BCB shall have the right to obtain any sponsor at its sole discretion.

## **10. EOI AND FINANCIAL PROPOSAL SUBMISSION**

- 10.1 Only the entities duly eligible to submit EOI as provided in clause 4 above are entitled to submit the EOI and Financial Offer/ Proposal. EOI and Financial Offer/ Proposal submitted by any entity that is not eligible as per requirement of eligibility clause, shall stand rejected forthwith.
- 10.2 The EOI Participants shall deliver to BCB the necessary EOI and Financial Offer/ Proposal (prepared in accordance with the Invitation to EOI Document) duly filled in and signed and sealed along with all supporting documents, including the receipt provided by BCB to the EOI Participant at the time of participation of the Invitation to EOI Document. EOI and Financial Offer/ Proposal must be delivered to BCB Management Office in a sealed envelope.
- 10.3 All documents and information that may be submitted by the EOI Participant shall be treated and kept "Strictly Confidential" and no part thereof shall, unless required in accordance with law / appropriate government authority / auditors, be disclosed to any third party.

- 10.5 The EOI Participant shall enclose the original EOI and Financial Offer/ Proposal (i.e. Electronic Version/ Scanned Copy) in an email attachment which is duly password protected and marked and addressed as follows:

- 10.6 If all the attachments are not sealed and marked as required by the EOI Document, BCB will assume no responsibility for the misplacement or premature opening of the EOI and Financial Offer/proposal.
- 10.7 BCB may, at its discretion, extend the deadline for the submission of EOI by amending the Invitation to EOI Document in accordance with Clause- 7 in which case all rights and obligations of the BCB and EOI Participants previously subject to the deadline shall thereafter be subject to the new deadline as extended. The BCB may in its discretion vary or extend the deadline.
- 9.10 No EOI and Financial Offer/ Proposal may be modified, substituted, or withdrawn after submission. No EOI and Financial Offer/ Proposal in torn condition or in unsealed covers would be accepted at the discretion of BCB.

However, BCB reserves the rights at its sole discretion to disclose the EOI And Financial Offer/Proposal received by it in public after acceptance of the Successful EOI Participant's offer in the EOI process.
- 11.1.4 7.5 BCB shall not be responsible for the TV production of the (i) New Zealand Team's Tour of Bangladesh 2026, (ii) Pakistan Team's Tour of Bangladesh 2026 (Test Series only), and (iii) Australia Team's Tour of Bangladesh 2026; however, BCB shall bear and pay the production costs. The financial offer shall be submitted in two options, one including production costs and the other excluding production costs, with the production level and technical specifications to be determined at BCB's sole discretion.
- 11.1.5 BCB reserves the right to accept or reject any or all EOI And Financial Offer/Proposal, without assigning any reason thereof.

## **11.2 EOI And Financial Offer/Proposal Confidentiality**

## **11.5 Post Qualification**

13.2 In furnishing this invitation, BCB does not undertake or agree to or acknowledge any obligation to provide to the successful EOI Participant any additional information or any roving quarries or to update this invitation or to correct any inaccuracies which may become apparent.

13.3 Neither the issue of this invitation nor any part of its contents is to be taken as any form of commitment or acknowledgment on the part of BCB to proceed with this invitation and BCB reserves the unfettered right to annul, terminate, reject any EOI or vary the EOI procedure at any time or stage without giving any reason.

13.4 BCB reserves the unfettered right to cancel the entire EOI process at any stage prior to execution of binding Agreement for reasons without assigning any reason.

- 13.5 BCB shall in no circumstances, whatever, including but without limitation, be responsible or liable in any manner or mode by whatever name called or describe for any costs or expenses whatsoever incurred or any loss whatsoever suffered in connection with or in consequence of the preparation or delivery of any EOI proposal, or compliance with or with a view to compliance with any of the requirements of the invitation by a successful EOI Participant in the subject matter of any departure from any of the provisions/conditions of the invitation.

#### **14. ACKNOWLEDGEMENT OF THIS INVITATION**

#### **16. GOVERNING LAW**

- 16.1 The validity, construction and interpretation of this Invitation to Document and the Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh) of the 01. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 Agreement (ANNEXURE - A) shall be exclusively governed and construed in accordance with the laws of Bangladesh.

#### **18 FORCE MAJEURE**

- 18.1 Failure on the part of either party to perform any of its obligations set forth in this Invitation to EOI Document/ EOI Document/ Agreement will not be deemed to be a breach of the EOI Document/ EOI Document/ Agreement to the extent that such failure arises as a result of an event of Force Majeure.
- 8.2 For the purpose of this clause, "Force Majeure" means an event or situation beyond the control of either BCB or applicant that is not foreseeable, in unavoidable and its origin is not due to negligence or lack of care on the part of either party. Force majeure shall include any civil commotion, strike, hartal, governmental action (i.e. change of law, withdrawal of cash intensive, etc.), lockout, accident, epidemic, commotion riot, civil unrest, Acts of God, cyclone; bad weather, any decisions of any government or regulatory authorities or any other event of any nature or kind whatsoever beyond the control of the parties that directly or indirectly hinders or prevents the parties from commencing or proceeding with consummation of the rights and obligations contemplate hereby.
- 18.3 If a Force Majeure situation arises, the applicant shall promptly notify the BCB in writing of such condition and the cause thereof. Unless otherwise directed by the BCB in writing, the applicant shall continue to perform its obligations under the EOI Document/ Agreement as far as is reasonably practical, and shall seek, all reasonable alternative means for performance not prevented by Force Majeure event.

## **19. LANGUAGES**

19.1 This tender document has been negotiated and executed in English Language which shall be the only language for the construction and interpretation of this document and all agreements, notices, documents, correspondence and instruments contemplated hereunder and, as among the Parties, the English version of any document required by any applicable law to be translated into another language for subsequent execution and delivery in such other language shall be the governing document and shall determine all rights and obligations of the applicant for all purposes .

## **20. WAIVER**

20.1 No failure or delay on the part of BCB in exercising any right or power hereunder shall operate as a waiver thereof nor shall any single or partial exercise of such right or power preclude any other or further exercise of any right or power hereunder.

## **21. SEVERABILITY**

21.1 In the event that any provision of this EOI Document/ Agreement shall be deemed or declared to be unenforceable, invalid or void, the same shall not impair any other provision of this Invitation to EOI Document/ EOI Document/ Agreement but BCB shall substitute a provision or amend the other provisions of this Document/ Agreement so as to produce a result which preserves as nearly as possible the economic balance of the Invitation to EOI Document/ Agreement, as the case may be, provided that neither party shall be obligated to accept an amendment which substantially departs from the essential intent or effect of this EOI Document/ Agreement.

**Bangladesh Cricket Board**, represented by its Chief Executive Officer **Mr. Nizam Uddin Chowdhury**, having its Office at, Sher-e- Bangla National Cricket Stadium, Mirpur, Dhaka 1216, Bangladesh duly authorized by its Board of Directors (hereinafter referred to as the “BCB” which expression unless repugnant to the context shall mean and include its successors-in-office, legal representatives, administrators, successors, assigns etc.) of the **FIRST PART**,

AND

**(Name - Media Rights Holder)** represented by its (Signatory Name & Designation and office Address), a private limited company incorporated under the Companies Act, 1994 of Bangladesh (hereinafter referred to as “**Media Rights Holder**”) which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns) of the **SECOND PART**.

**BCB** and **(Name - Media Rights Holder)** are hereinafter collectively referred to as the 'Parties'.

WHEREAS, **BANGLADESH CRICKET BOARD**, an affiliated sports organization under the National Sports Council Act, 2018 having the authority to regulate and promote the game of cricket in Bangladesh published an “**Invitation to EOI for Worldwide Media Rights of 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026**” Advertisement dated 12<sup>th</sup> March 2026, later invites Expression of Interest (EOI) along with financial offers from the TV Broadcasters or Marketing Agents for acquiring the following Media Rights (I). Category A: Financial Offer including Production Cost (ii). Category B: Financial Offer excluding Production Cost of 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026 to be held in **2026** for worldwide and territory of Bangladesh. The said Media Rights include (i) Satellite TV (linear) Rights, (ii) Digital OTT (Over-the-Top) Rights of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team’s Tour of Bangladesh 2026.

AND WHEREAS, the Bangladesh Cricket Board (“BCB”) invited Expressions of Interest (“EOI”) from interested parties for the acquisition of Worldwide Media Rights (including Satellite TV – Linear, Digital OTT – Over-the-Top, and Radio) for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team Tour of Bangladesh 2026; matches scheduled to be held in 2026.

AND WHEREAS, the EOI Participants submitted their EOIs along with their respective financial offers for the said rights. Following the necessary scrutiny and evaluation process in accordance with the EOI terms, (Name of the EOI Participant), being the highest and most competent offeror, has been selected and

awarded the Worldwide Media Rights for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team Tour of Bangladesh 2026, subject to the terms and conditions set forth herein.

**NOW THEREFORE IN CONSIDERATION OF THE MUTUAL COVENANTS CONTAINED HEREIN THE PARTIES HERETO AGREE AS FOLLOW:**

**1. Definitions**

**"Applicable Law"** means all applicable statutes, laws, ordinances, rules and regulations, including but not limited to, any license, permit or other governmental Authorization, in each case as in effect from time to time;"

**"Archive Rights"** means the right to the BCB Archive Materials and the right to market and sell clips of footage to any person for the purposes of inclusion of the same within any advertising or commercial or Mobile /VAS Service Provider, any compilation or other program for distribution and/or exhibition on or by means of any media. The Archive, by its definition, includes any length Video, starting from Near-Live to Full Match.

**"BCB Archive Materials"** means all future BCB Footage 12 (Twelve) hours after it is broadcast live.

**"Audio Rights"** means the right to transmit and the deliver by the means of radio delivery and any simulcast of such transmission by any permitted delivery system, the audio feed and/ or unilateral commentary as part of, and for inclusion in, any audio only service or programs.

**"Audiovisual Coverage"** means any and all audio-only, still and moving visual- only and audiovisual material, data and textual material (including, without limitation, the Feed, Audio Feed and Unilateral Coverage) of, and/or relating to, the BCB Events.

**"BCB"** means the Bangladesh Cricket Board, the governing body authorized to regulate and promote the game of cricket in Bangladesh and recognized under the National Sports Council Act 1974 with its Office at Sher-e-Bangla National Cricket Stadium, Mirpur-2, Dhaka 1216, Bangladesh, and its successors and assigns.

**"Ancillary Rights"** means any and all allied, underlying and ancillary rights in and to the BCB Events including, without limitation, merchandising, ticketing and hospitality rights, Guide Commentary, Graphics, soundtrack, sound recordings, any rights in musical compositions and/or lyrics, photographic/still imagery rights and any other exploitation of rights in and to the BCB Events whatsoever (whether now known or hereafter created and whether or not in the contemplation of the parties) not expressly encompassed within the Rights;

**"AR/VR Rights"** means the right to exploit Footage and/or Archive Material, and the BCB Events in any way, by means of Augmented Reality and/or Virtual Reality;

**"Audio Rights"** means the transmission of audio coverage of Matches (or any adapted, altered or edited version thereof, and including comment, commentary, interviews and/or associated Match data) whether live, delayed, highlights or report in all languages via any Delivery System now known or hereafter developed which is capable of transmitting or making available audio material for reception anywhere within the Licensed Territory, including via analogue and/or digital radio broadcasts, audio streaming/broadcasts to mobile phones and the right to stream such audio coverage via the Internet and/or simulcast radio broadcasts via an audio Internet stream, and/or make such audio content available on demand, including the provision of downloadable audio content commonly called podcasts;

**"Augmented Reality"** means any audiovisual footage and/or program that has been augmented by means of objects and/or information being integrated within and/or overlaid onto such audiovisual footage and/or program using any arrangement, apparatus, device, process or procedure, whether now known or hereafter devised;

**"Cinema Screening Rights"** means the right to exhibit the Live Transmissions that the Licensee makes in exploiting the Live Rights via the Designated Channels on a screen (or screens) in conventional and/or drive-in cinemas located in the Licensed Territory (and including the right to charge an admission fee);

**"Event Documentary"** means any documentary program, series or film which focuses on one or more BCB Events and/or BCB Member teams in one or more years and which may be made in a behind-the-scenes format including interviews with, and/or footage of, cricketers, coaches, support staff, team officials, and match officials participating in the such relevant BCB Event(s) and/or otherwise involving BCB Member team(s), and may include Archive Material, Footage and Unilateral Footage;

**"Event Documentary Rights"** means the right to produce, transmit, exhibit or otherwise make available Event Documentaries via any Delivery System now known or hereafter developed anywhere within the Licensed Territory;

**"Fixed Media"** means the technological device or system of reproducing and distributing audio, visual and audiovisual material including all electronic, optical, magneto-optical, magnetic or mechanical storage devices now known or hereafter invented including VHS, VCD, DVD, CD-ROM, Blu-Ray Discs, laser discs, UMDs, memory sticks and cards, hard drives and any other storage device and all products and all materials associated therewith on all systems, including online or Internet based formats such as DTO;

**"Fixed Media Rights"** means the right to record, edit and incorporate Footage and/or Archive Material in any Fixed Media for: (a) sale or hire or license to the general public; (b) non-commercial coaching and educational purposes; (c) BCB internal reporting and archive purposes; (d) exhibition at any cricket academy operated by or on behalf of BCB ; and (e) use by BCB or Sponsors for BCB Event promotions, in each case after the expiry of the Exclusivity Period for the relevant BCB Event save in respect of (b) which may be undertaken at any time during the Term (including in particular by BCB Partners / Sponsors during the Exclusivity Period of the relevant BCB Event);

**"Interactive Game"** means any audiovisual, console, electronic or mobile competition, contests or game which is played on any device (including a Mobile Device) or by using any game console, whether or not connected to a television, which may include (inter alia) non-Live Footage and/or material based on or deriving therefrom and including any fantasy league-type and/or NFT-based game or competition relating to any BCB Event;

**"Interactive Game Rights"** means the right to engage in and/or authorize third parties to engage in the development, copying, distribution, exhibition and/or other exploitation of Interactive Games (including by means of any Delivery System);

**"Mobile Activation Rights"** means: (i) the right to develop, produce and distribute BCB Event Apps; and (ii) the right to make available score updates, wicket alerts and/or other BCB Data from Matches, via SMS or MMS or otherwise;

**"News Access Rights"** means the right to Transmit Clips not exceeding 90 (ninety) seconds per Match (or such longer minimum as may be permitted by Applicable Law): (a) within a news program or a sports news program delivered by any Delivery System; or (b) as a non-commercial editorial standalone clip delivered by any Delivery System on a predominantly news or sports portal, such right to be granted on a national or multinational basis, to media organizations and/or news gathering and dissemination organizations

**"Non-Fungible Token" or "NFT"** means any blockchain-tracked, non-fungible token, such as those conforming to the NFT standards ERC-721 or ERC-1155 or comparable non-fungible token standards on any other blockchain platform, such as Flow, Polygon, Ethereum, Solana, Polka dot, Cosmos, and Avalanche;

**"Public Screening Rights"** means the right to:

(a) Transmit any Footage by any Delivery System on a screen (or screens) in any place other than a private residential household and to admit the general public to such place (with or without charging an admission fee), including by means of: (i) the exploitation of the Closed Circuit Rights; (ii) exhibition in conventional or drive-in cinemas, licensed as such in the place where the exhibition occurs, that are open to the general public on a regularly scheduled basis; (iii) exhibition before an audience at the facilities of organizations not primarily engaged in the business of exhibiting Footage (including educational organizations, churches or other religious groups, libraries, or governmental bodies such as in embassies, armed forces bases, armed forces vessels and other governmental facilities flying the flags of any parts of the Licensed Territory); and (iv) exhibition in any Fan Zone; and

(b) Transmit any Footage by any Delivery System on any screen(s) used for general advertising purposes in any publicly accessible place,

**"Transportation Rights"** means the right to transmit, exhibit or otherwise make available the Live Feed, BCB Highlights Programmes, Trailers and/or BCB Produced Programmes by any Delivery System by means of any media whatsoever on any form of transport including via any in-flight or on-board entertainment system aboard any aircraft, ship, motor vehicle (including a car, bus, and coach) or train anywhere in the world;

**"Archive Rights"** means the right to transmit, exhibit or otherwise make available Archive Material via any Delivery System now known or hereafter developed anywhere within the world, including the right to make available recordings of the Live Feed of each Match of the 1. New Zealand Teams Tour of Bangladesh 2026 (02). Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 in which its team participates to each bilateral series opponent of BCB for Transmission on digital services owned and operated by BCB for noncommercial, editorial purposes;

**"Remote Hospitality Screening Rights"** means the right to Transmit any Footage on a screen (or screens) in the Licensed Territory as part of a premium home-based hospitality experience;

**"Reserved Clip Rights"** shall mean the exclusive rights retained by the Bangladesh Cricket Board (BCB) in relation to each Match, as follows:

(a) The right for BCB to make available within the Licensed Territory:

(i) Video clips (in any aspect ratio) of up to **six (6) minutes** in total per hour of live match play, which may be published **during the Match**, and, in respect of the **final hour of play, immediately after the Match concludes**; and

(ii) Video clips (in any aspect ratio) of up to **ten (10) minutes** in total duration, which may be published **after the conclusion of the Match**, in each case for transmission or publication through any delivery platform, including BCB's official digital media assets (e.g., websites, mobile apps, and social media channels).

(b) The right to **sub-license** the above Clip Rights to **third parties**, including official sponsors and commercial partners, enabling such third parties to distribute:

- (i) Clips (in any aspect ratio) of up to **six (6) minutes** per hour of live play during the Match and immediately after the final hour of play; and
- (ii) Clips (in any aspect ratio) of up to **ten (10) minutes** following the end of the Match, through one or more delivery platforms simultaneously.

**Business Day** means any working day excluding weekends and national and/or bank holidays in Bangladesh, as declared by the Government of Bangladesh. Any other reference to “days” shall be calendar days.

**Ceremony** means any official pre- or post-Match presentation, including but not limited to any Flash Interview, Spectators’ engagement Interview, Participating teams’ Interview during the match, Prize- Giving and the Opening / Closing Ceremony of the 1. **Reserved / Excluded Rights** means The Rights granted to the successful Bidder shall represent the entire extent of the rights granted to it. All other rights to, and means of exploitation of, the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026**. Data from Matches, via SMS or MMS or IVR or otherwise, by means of Mobile Technology.

**Permitted Delivery System** means any form of Television Delivery, OTT platform, mobile, internet etc.

**Production Company or Event Producer** means any company hired by the Bangladesh Cricket Board (BCB) BCB to do the LIVE TV production and to undertake the production of BCB Events (i.e. the 1. News syndication rights in the Bangladesh Territory will be done by the BCB on its own.

s) Major Sponsorship rights (i.e. Title sponsorship, Co-sponsorship, Associates Sponsorship) and All in-stadia advertising rights (i.e. Ground Boards, Mid-Walls, Sight Screens, Score Boards, Boundary Ropes, Pitch Mat, Bowling Ends, Umbrella, Stumps Branding, Dug-out Branding etc.)

t) Sponsorship, hospitality, merchandising and ticketing rights in respect of the BCB Events

Archive Rights. However, the Broadcaster shall be able to use the image/clip of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh till the date of expiration of the agreement.

u) Sponsor clip rights - the right for BCB Sponsors to use clips of up to two (2) minutes of Footage of each Match in any media for the promotion of the product/services and for the brands in respect of which BCB has granted them promotional and/or marketing rights provided that:

v) BCB will put in place an approval process for the use of such clips;

(l) No more than twenty (20) seconds of such Footage shall be included in any television advertisement; and

(m) Such clips of Footage shall not be used in any other audio-visual programming intended for transmission.

(n) Closed circuit television - for the avoidance of doubt, BCB shall be entitled to use the Live Feed of a Match without payment so that such feed can be:

(o) Simultaneously relayed by way of closed-circuit television and/or screen or projection facilities (including so-called "big-screens") and to press box and hospitality suites at the Venue at which the relevant Match is played;

(p) Used for the "third umpire" and disciplinary purposes; and

(q) Used for the purposes of exploiting any of the Excluded Rights.

Inflight /On-board Rights- all rights to transmit, deliver and/or exhibit, by means of any media whatsoever, any audio-only, still or moving visual-only or audiovisual material relating the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026. (including, the Feed), whether on a live basis or otherwise, for reception and/or exhibition by means of any in-flight or on-board entertainment system aboard any aircraft, ship, train or other form of transport anywhere in the world; and all rights to exploit any and all commercial opportunities (including, for example, broadcast sponsorship and commercial airtime opportunities) arising from, and/or in connection with, each such transmission and exhibition.

### **2.3 Minimum Transmission Requirements**

In connection with the Rights, the Media Rights Holder must ensure that the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh are transmitted live in Bangladesh. The Media

Rights Holder must provide free live feed to the national Broadcaster, i.e. Bangladesh Television (BTV) and Bangladesh Betar.

BCB shall be responsible for the TV production of (i) the New Zealand Team's Tour of Bangladesh 2026, (ii) the Pakistan Team's Tour of Bangladesh 2026 (Test Series only), and (iii) the Australia Team's Tour of Bangladesh 2026, in the event BCB accepts a Financial Offer excluding production cost (Category B). However, if BCB accepts a Financial Offer inclusive of production cost (Category A), the Media Rights Holder shall be responsible for the TV production and shall comply with the technical specifications set out in the Annexure C subject to BCB's sole discretion.

BCB reserves the right to have full control over the outsourcing/hiring production team/firm/company and necessary equipment to be appointed by the BCB. It has been agreed between the parties (i.e. BCB and Media Rights Holder) that all matches of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 shall be broadcasted in accordance with the terms set out by the ICC (International Cricket Council) in Minimum Standard for Live TV Production (**PRODUCTION LEVEL AND RELEVANT SPECIFICATION [Annexure B]**), technical or otherwise, prescribed by the ICC. In case of any change in the ICC Broadcasting regulations/Broadcasting Guidelines or standard (technical or otherwise) prescribed by ICC, the BCB must ensure that all matches of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 shall be broadcasted upon complying with the said changes/modifications/upgradations at BCB's own costs. At all material times the minimum production requirements of the matches the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 must be complied with.

Any breaches from the Media Rights Holders' end shall be considered as a fundamental breach and, in which event, BCB shall be at liberty to take necessary legal action including but not limited to termination of Agreement, financial penalties etc.

Full match must be broadcasted (every single ball played must be televised LIVE) on match days where the BCB shall ensure maximum brand exposure of the sponsors of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026. In-Stadia branding should be prominently visible as per the standard practice (i.e. pitch mat, ground/perimeter boards, boundary ropes, sight screens, bowling end name display, co-sponsor/powered by sponsor etc.) during the game. Any breaches in this regard shall be considered as a fundamental breach. In case of such breach, BCB reserves the right to take necessary legal action including but not limited to termination of the Media Rights Agreement.

(iii) Ceremonies - BCB will organize, after each Match, a prize giving ceremony of no more than 15 (Fifteen) minutes duration which must be transmitted live in each Territory. If there are "Opening and Closing Ceremonies" or any relevant events including Flash Interview, Spectators' engagement Interview, Participating teams' Interview during the match for, the BCB shall ensure they are carried live without any interruptions of any manner. However, broadcasting rights of opening ceremony is "Excluded Rights".

(iv) BCB reserves the right to transmit install match Clips, Highlights of the Match or Ceremony immediately after such Match or Ceremony on the BCB digital Platforms and Website. BCB intends to market the BCB Website. It will in no way impinge on the live rights so granted under this agreement. The Media Rights Holder fully acknowledges that BCB Archival Materials will be available on the BCB Website in the near future.

(v) The Media Rights Holder shall at BCB's request provide unedited and broadcast quality footage of all post-match/day media conference for download from a dedicated FTP site (created and maintained by the Media Rights Holder) within 60 minutes of the conclusion of the press conference. The purpose of this requirement is to protect the rights.

(vi) Territorial Laws - The Media Rights Holder will ensure that transmissions of the Audiovisual Coverage (or any part thereof) and all activities undertaken in connection with the Rights must be in full compliance with, and subject to, all applicable laws of the relevant Licensed Territory including, without limitation, local laws relating to the television coverage of designated events of major importance to society (if any).

(vii) The Media Right holder shall not promote any brand conflicting with any of the sponsoring brand of the tournament. Further, all branding must be done with the approval of BCB and the Broadcaster undertakes to comply with the branding guidelines as follows:

1. **Commentary box backdrop** – Must contain BCB Logo, Event Logo, and Title Sponsor Logo along with Broadcaster Channel Logo. 50% of such backdrop must contain BCB Logo, Event Logo and Title Sponsor Logo.

2. **In-studio backdrop** - Must contain BCB Logo, Event Logo, Title Sponsor Logo along with Broadcaster Channel Logo and Broadcaster's Partner(s) Logo. 50% of such backdrop must contain BCB Logo, Event Logo & Title Sponsor Logo.

3. **Interview and Commentary Microphone** – Microphone flag branding must not exceed **57 mm X 48 mm** for **4 sides** where **Event & BCB logo** should be on at least 2 sides. Broadcaster's logo(s) should not be placed side-by-side. Microphone flag branding must not exceed **89.5 mm X 48 mm** for **3 sides** where Event logo should be on at least 1 side.

4. In TV production and other media i.e. internet deliveries – Logo & Brand visibility of event logo, BCB, Major sponsor, co- sponsor and associate sponsor of the tournament must be prominently visible.

Media right holder undertakes to comply with any further instruction/request of the BCB with regard to promoting brands during the live telecast or issued from time to time.

2.4 For the avoidance of doubt, the Excluded Rights are hereby reserved to BCB for its own use, exploitation and benefit without any limitation or restriction whatsoever, and the Media Rights Holder shall not permit any third party to, assert, represent or claim that they have any right, title or interest whatsoever to any of the Excluded Rights.

2.5 This Agreement shall remain valid throughout the Period as defined in Clause 1 above.

### 3. Rights Fees and Financial Guarantee:

3.1 In consideration of the grant of the Media Rights by BCB, the Media Rights Holder shall pay to BCB the Rights Fee in accordance with the following provisions:

The Media Rights Fee of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh. is **BDT** ...../- (in word only) exclusive of VAT and Taxes.

**i) Rights Fee Payment Terms**

**The following payment structure shall apply in respect of the Worldwide Media Rights (Satellite TV – Linear and Digital OTT - Over-the-Top Rights - Worldwide including Bangladesh) Fee, i.e., the Offered Value for the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 must be paid by the successful EOI Participant to BCB in the following manner**

- **1st installment- 25% of the total offered value shall be paid to BCB prior to start the Bangladesh vs New Zealand Series. (i.e.10th of April 2026)**
- **2nd installment – 25% of the total offered value shall be paid to BCB prior to start the Bangladesh vs Pakistan Test Series (i.e. 1st of May 2026)**
- **3rd installment – 25% of the total offered value shall be paid to BCB prior to start the Bangladesh vs Australia Series (i.e. 1st of June 2026)**
- **4th installment- 25% of the total offered value shall be paid to BCB within 15 days from the completion of Bangladesh vs Australia Series (i.e. 5th of July 2026)**

**Bank Guarantee (BG) Requirement:**

The successful EOI Participant must submit to BCB a Pay Order or an unconditional and irrevocable Bank Guarantee as per BCB standard format (ANNEXURE - B) for the sum of 75% of the NET offered value accepted by BCB in favor of "Bangladesh Cricket Board" that is valid for a period of at least Four Months within 72 hours from the issuance of Letter of Intent (LOI).

(iii) Media Rights fees are NET amount and excluding of VAT/Tax & any other deductions.

- 3.2 Time is of the essence in relation to the Media Rights Holder’s payment obligations hereunder and in case of any delay in payment, BCB shall have the right to terminate this agreement in accordance with clause 5.1(b) of this Agreement and seek to recover loss and damages from the Media Rights Holder. Without prejudice to such rights, the BCB shall be entitled to charge interest on any late payment of any amount including any installment of the Rights Fee at rate not to exceed LIBOR plus 3%.
- 3.3 All amounts due under this Agreement as per clause 3.1 and 3.2 shall be paid by the Media Rights Holder within the timeframe stipulated in Clause 3.1(ii) & 3.2 above, and clear of, and without deductions based on production costs and expenses, any currency control restrictions, import duties, or any sales, use, value added or other taxes or withholdings of any nature whatsoever. In the event the Media Rights Holder is required to make any deduction or withholding in respect of any taxes, imposts, duties or other such charges in respect of any payment into the Designated Account hereunder, the Media Rights Holder shall gross up the relevant amount to ensure that BCB receives in the Designated Account the full cash amount that it would otherwise have been entitled to receive.
- 3.4 The payment obligation of the Media Rights Holder is unconditional and independent of all its other rights and/or obligations under this or any other contract(s).
- 3.5 For the purpose of securing the Media Rights Holder’s obligation to pay Rights Fee into the Designated Account in accordance with the foregoing provisions of this clause 3, the Media Rights Holder irrevocably and unconditionally agrees to provide BCB with irrevocable financial guarantees in the form of a Bank Guarantee as set out in Clause 3.1(iii).
- 3.6 Where a particular payment is subject to tax, deduction or withholding tax or otherwise, the amount payable to BCB shall be grossed up to the amount of the deductible tax/withholdings and all payments to BCB shall be payable clear of all taxes, deduction and withholdings of whatsoever nature.
- 3.7 Upon completion of the full payment the bank guarantee will be released by BCB
- 3.8 The BCB shall appoint the Production Company and shall also be responsible for hiring of commentators, anchors, camera crews, talk show expert/ guest/ cricket expert, technicians, necessary equipment, graphics and statistical inputs, upon. All costs associated with the TV production shall be borne by the BCB.

BCB reserves the right to have full control over the outsourcing/hiring production team, necessary equipment. However, all necessary permissions, consents and licenses, including but not limited to permission from Bangladesh Bank, Bangladesh Television, Bangladesh Betar, National Board of Revenue, the Bangladesh Telecommunication Regulatory Commission and any other permissions from the Government of Bangladesh or any other Government of State or any other Country including relevant Ministry / Department shall be obtained by the Media Rights

Holder for due performance of its obligations under this Agreement and the BCB shall in no way responsible for obtaining such permission.

- 3.9 The Media Rights Holder shall act at the instructions of BCB in its marketing campaigns and priorities and shall ensure full compliance with all BCB rules, regulations and policies as applicable and amended from time to time including the ICC and ACC rules and regulations and all BCB statutory and contractual obligations.
- 3.10 The Media Rights Holder shall indemnify BCB in full and hold it harmless against any loss and/or damages and/or claim and/or legal proceedings and/or actions of whatever nature incurred by BCB in relation to and/or arising out of, but not limited to, any Sub-License Agreement.

#### **4. Representations and Warranties:**

- 4.1 The Media Rights Holder hereby represents and warrants to BCB that:
- (a) it has the full right and legal authority to enter into, and is fully capable of performing its obligations under this Agreement in accordance with its terms;
  - (b) the persons signing this Agreement have been duly authorized by the board of directors of the Media Rights Holder and no other action is, or will at any time during the Agency Period be, necessary to authorize the signature and entry into of this Agreement or the performance of any obligation provided for in or contemplated by this Agreement;

In this regard copy of both companies (i.e. companies under the consortium agreement) board resolution and Joint Venture/Consortium Agreement needs to be provided to BCB.

- (c) in executing, undertaking the obligations to perform and performing the terms and conditions under this Agreement, the Media Rights Holder is not in breach of any obligations nor duties owed to any third parties and will not be so as a result of performing its obligations under this Agreement. It also represents that by entering into this Agreement or performing its obligation, under the agreement, it is not in breach of any law;

It shall ensure and procure that in exploiting the Rights under this Agreement, it shall not make or distribute any obscene, libelous, blasphemous or defamatory content or statement or anything which infringes the copyright or other intellectual property rights of any third party or which is materially prejudicial to or affects or impairs the image of the game of cricket, the matches of the 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh the BCB or the participating teams;

- (d) The Media Rights Holder shall be responsible for all and any costs, expenses, taxes, levies and impositions incurred in exploiting the Rights under this Agreement;
- (e) It shall abide by all relevant rules, regulations, orders, statutory impositions or restrictions whether imposed by national laws or any competent authority responsible directly or indirectly, in exploiting the Rights under this Agreement and shall obtain all relevant approvals, permissions and consents as are required by statute from time to time; and
- (f) It shall comply with all Broadcasting Guidelines issued by BCB and/or ICC from time to time.

Subject to Clause 2.3(viii), the BCB shall notify the Media Rights holder, the confirmed /final production details, name of commentator(s), final production details, name of commentators, footprints and Media Rights holder shall notify BCB the name of broadcasting TV channel outside the territory of Bangladesh etc. no later than at least 10 (Ten) days prior to 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026.

The Media Right Holder shall not transfer the rights and obligations under this agreement to any other Broadcaster or Marketing Agent without prior written approval of BCB. The Media Rights Holder understands and acknowledges that the decision to grant approval to any transfer of rights and obligation shall be at the sole/absolute discretion of BCB.

- (g) The Media Right Holder shall not entertain any request made by any person either in their personal or professional capacity for any sort of exposure during live telecast unless such exposure has been approved only by the Chief Executive Officer (CEO) of BCB.
- (h) The Media Right Holder shall be liable to pay compensation to BCB for causing any loss or damage to any property of the stadium during their presence therein.
- (i) The Media Right Holder (Name) shall be severally liable to discharge/perform and comply with all the terms and conditions of this Agreement.

4.2 BCB hereby represents and warrants to the Media Rights Holder that:

- (a) It has the full right and legal authority to enter into and fully perform this Agreement in accordance with its terms including the right and authority to grant to the Media Rights Holder the rights and benefits set forth herein;
- (b) The Rights are and remain free and clear of liens, encumbrances, charges and claims and will not infringe any intellectual property, privacy or other rights of any entity;
- (c) It shall procure unrestricted access to all Venues at all reasonable times prior to, during and after the Matches for the purposes of exploiting the Rights, including in relation to production, recording and transmission services. In particular, BCB shall procure that unrestricted access is provided at all reasonable times and at no charge for the personnel of the Media Rights Holder and the Production Company for the purposes of installing, constructing and de-constructing any equipment, provided however that the costs of consumption of all telecommunications services shall be paid by the Media Rights Holder;
- (d) BCB shall also provide the Media Rights Holder with the following:

**Hospitality Box:** 01 (one) exclusive hospitality box having minimum 16 seats tickets shall be provided to the Sponsor. Sponsor or their nominated representatives will be invited in every match of 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026

**Accreditation Cards:** The Sponsor and their nominated representatives and Production team will be given adequate accreditation cards and duty passes to execute their operation.

- i) **Car Parking Stickers:** The Sponsor will be provided necessary Car Stickers for the matches

comprising the category as follows: Pick & Drop, Inside parking (VIP) outside parking.

## **5. Termination:**

- 5.1 BCB may terminate this Agreement immediately by a written notice to the Media Rights Holder if:
- (a) the Media Rights Holder is adjudicated insolvent, involuntarily declares bankruptcy, makes a general assignment for the benefit of creditors, or fails to continue its business of broadcasting and /or event management or agency business; or
  - (b) the Media Rights Holder fails to make payment to BCB of any sums due; or
  - (c) the Media Rights Holder fails to provide/furnish any bank guarantee to Bank Guarantee within the stipulated timeframe specified in the Agreement; or
  - (d) the Media Rights Holder breaches any warranty or other term of this Agreement (other than terms on payment of Right Fee, Production Cost and furnishing Bank Guarantee which must be paid as per schedule), which breach the Media Rights Holder fails to cure, if curable, within Fifteen (15) calendar days of BCB's notice to the Media Rights Holder of any such breach; or
  - (e) the Media Rights Holder undergoes a change of control, where such change of control has a material impact on the Rights in the reasonable opinion of BCB.

the Media Rights Holder fails to broadcast LIVE every single ball played on match days and the Media Rights Holder fails to ensure maximum brand exposure of the sponsors and In-Stadia branding of 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 which should be prominently visible as per the standard practice (i.e. pitch mat, ground/perimeter boards, boundary ropes, sight screens, bowling end name display, co-sponsor/powered by sponsor etc.) during the game.

- (g) Notwithstanding the above, this agreement will stand as automatically terminated if the Media Rights Holder fails to make any payments to BCB as per the terms of this Agreement.
- 5.2 BCB may, without prejudice to its other rights under this Agreement or at law, suspend performance of its obligations under this Agreement or any of them, during any period in which the Broadcaster is in breach of any of its obligations under this Agreement including, by way of example only, its obligation to pay any Rights Fee (or any installment thereof) to BCB when due. Where such breach does not involve any failure to pay the Rights Fee or to deliver any bank guarantee when due, BCB shall suspend performance only of those of its obligations which relate to the BCB Event in respect of which the breach has occurred and then only in a manner which is, in the reasonable opinion of BCB, proportionate to the breach.
- 5.3 Subject to clause 5.1(b) and (d), failure of the Media Rights Holder to comply with any of the provisions of Clause 3 will entitle BCB to immediately, without any prior notice, terminate this Agreement and it will be open to BCB to enter into a private arrangement/negotiation for some or all of the Rights with another 3rd party until a fresh tender is finalized in order to meet its ongoing requirements. All expenses incurred by BCB until the fresh tender is finalized to meet its requirements resulting from a breach by the Media Rights Holder of the provisions of Clause 3 will be at the risk and cost of the Media Rights Holder.

## **6. Consequences of Termination:**

- 6.1 Upon expiry or termination of this Agreement for any reason whatsoever:
- (a) All of the Rights shall forthwith revert to BCB;
  - (b) The Media Rights Holder shall immediately cease to exercise and exploit the Rights, BCB Marks, and the Home Series Event marks and shall not thereafter use or exploit its previous connection with BCB or any of the BCB Events, whether directly or indirectly;
  - (c) BCB shall immediately thereafter be entitled to grant all or any of the Rights to any third party;
  - (d) BCB and the Media Rights Holder shall promptly return to the other all property of the other within its possession;
  - (e) The Media Rights Holder shall forthwith remit to the Designated Account the balance of the Rights Fee and any other sums that are outstanding and to be accounted for under this Agreement; and
- 6.2 Save where expressly stated otherwise, the expiry or termination of this Agreement shall be without prejudice to any rights already accrued to either of the parties under this Agreement.

## **7. Indemnity:**

The Media Rights Holder indemnifies and hereby keeps BCB indemnified fully from and against all claims, demands, actions, proceedings, damages, liabilities, costs and expenses whatsoever (including legal fees and expenses actually incurred) arising directly or indirectly out of any breach or non-performance by the Media Rights Holder of any or all of its obligations, undertakings, warranties or assurances specified herein.

## **8. Series itinerary and Venue:**

The BCB reserves the right to make any changes to the declared schedule of Matches of 01. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. BCB undertakes to advise the Media Rights Holder as soon as practically possible of any such changes.

For avoidance of doubt, BCB reserves the right to schedule, re-schedule, cancel, partially cancel, postpone, relocate, curtail of matches, of 1. New Zealand Teams Tour of Bangladesh 2026 02. Pakistan Teams Tour of Bangladesh 2026 (Test Series only) 03. Australia Teams Tour of Bangladesh 2026 Team's Tour of Bangladesh 2026 at any time at its sole discretion. Under no circumstances shall BCB be liable for any change of Schedule of Matches, any change of law or any governmental decree or action which impacts, or may impact, on the Matches or the Rights.

## **9. Compensation**

10.2 Other than expressly set out herein, the Media Rights Holder shall not adopt, create or begin to use:

- (a.) any registered or unregistered trademarks owned or used by BCB including, without limitation, the BCB Mark and BCB Event Marks in any language whatsoever; or
- (b.) any term which is confusingly similar to, is a colorable imitation of, or is a derivation of, or which unfairly competes with, any such trademarks.

The Media Rights Holder shall not oppose any of the trademark or copyright applications filed by BCB or its affiliates, nominees or authorized agents in respect of any of the BCB Marks and the Home Series Event Marks. The Media Rights Holder and/or any Sub-Licensee shall not in

any way challenge, or apply for any copyright, trademark, or patent protection, or domain name registration (whether in respect of, or in relation to, any of the BCB Marks or the Home Series Event Marks or otherwise), which would adversely affect BCB's proprietary, interests in the same, or assist any person to do so.

10.3 All Intellectual Property (including, without limitation, copyright) that subsists in the Feed, Footage, Audiovisual Coverage and International Commentary (including transmissions and recordings thereof by the Media Rights Holder and each Sub-Licensee) shall vest in, and be owned by, BCB for the full term of copyright including all renewals, reversions and extensions thereof and thereafter in perpetuity.

Either party shall be entitled to any and all remedies available at law or in equity, including injunctive relief, in the event of any breach of such commitment to confidentiality. However, this will not apply to right fees agreed by the Media Rights Holder. The Media Rights Holder shall not be permitted to hold a press conference in relation to the awarding of the Rights without the prior consent of BCB.

## **12. Waiver:**

12.1 The failure at any time of the Media Rights Holder or BCB to demand strict performance by the other of any of the terms, covenants or conditions set forth herein shall not be construed as a continuing waiver or relinquishment thereof, and either party may, at any time, demand strict

and complete performance by the other of such terms, covenants and conditions.

**13. Assignment:**

The Media Rights Holder shall not assign, at law or in equity (including by way of a charge or declaration of trust), transfer, charge or deal in any other manner with this Agreement or any rights or obligations under this Agreement, or sub-contract any or all of its obligations under this Agreement except with the prior written approval of BCB. BCB shall be entitled to assign its rights and obligations under this Agreement to any entity incorporated as a subsidiary of BCB in its absolute discretion.

#### **15. BCB/Broadcasting Right Holder Relationship:**

Nothing contained in this Agreement shall be construed as establishing an employer/ employee relationship or joint venture or partnership determined pursuant to instructions issued by BCB to the Media Rights Holder and BCB shall not be responsible in any way for acts or omissions of the Media Rights Holder beyond the scope of its authority, whether implied, apparent or otherwise under this Agreement.

#### **16. Remedies:**

In the event either party breaches any term or condition of this Agreement, the non-breaching party shall seek interim relief only from the tribunal of arbitrators as set out in clause 17 below only, provided that nothing shall prevent either party from seeking urgent injunctive relief through the courts of Bangladesh in order to protect their rights under this Agreement.

The place of arbitration shall be Dhaka, Bangladesh and the language of arbitration shall be English. The decision of the arbitral tribunal shall be final and binding.

17.4 The parties hereby agree any award of the tribunal may be enforced in any court of competent jurisdiction.

17.5 Notwithstanding the above, any Bank Guarantee furnished by the Media Rights Holder under this Agreement shall not come within the purview/scope of this arbitration clause.

#### **18. Section Captions:**

Section captions contained in this Agreement are for reference purposes only and are in no way intended to describe, interpret, define or limit the scope, extent or intent of the Agreement or any provision hereof.

#### **19. Entire Contract:**

Upon execution, this Agreement shall constitute the entire understanding between the parties and, as such, may not be altered or modified except by an agreement in writing signed by all parties. Any previous agreements or understandings between the parties on the subject matters herein shall have no further force or effect.

**20. Severance:**

If any provision of this agreement shall be found by any court, government or administrative body, of competent jurisdiction, to be invalid or unenforceable, the invalidity or un-enforceability of such provision shall not affect the other provisions of this agreement and all provisions not affected by such invalidity or unenforceability shall remain in full force and effect. The parties hereby agree to attempt to substitute for any invalid or unenforceable provisions with a valid or enforceable provision, which achieves to the greatest extent possible the economic, legal and commercial objectives of the invalid or unenforceable provision.
