



## **GENERAL GUIDELINE**

#### **INTRODUCTION:**

Since its inauguration in 1974–75 the league has been the premier club cricket competition in Bangladesh. It gained List A status starting with the 1<sup>st</sup> edition of Dhaka Premier Division Cricket League (DPDCL) in 2013–14.

After successful completion of the season 2018-19, the Bangladesh Cricket Board (BCB) hereby invites Expression of Interest (EOI) along with financial offers from the reputed business houses/ companies/parties/agencies for the TITLE SPONSORSHIP AND GROUND BRANDING RIGHTS of Dhaka Premier Division Cricket League (DPDCL) for 03 seasons i.e. 2019- 20, 2020- 21 & 2021-22

To commemorate birth centenary of the founding father of the Nation Bangabandhu Sheikh Mujibur Rahman, DPDCL season 2019-20 will be called **"Bangabandhu Dhaka Premier Division Cricket League 2019-20"**.

# FORMAT:

The competition is played as a round-robin, followed by play-off rounds among the top six teams for the championship and among the lowest three teams to determine relegation.

#### COMMENCEMENT:

Bangabandhu Dhaka Premier Division Cricket League 2019-20 will kick-off from 15<sup>th</sup> of March, 2020 and will end at 8<sup>th</sup> May, 2020 (Tentative).

Note:

- 1. Schedule for **Bangabandhu Dhaka Premier Division T20 Tournament 2019-20** will be declared in due course and the right fees will be determined mutually by BCB and the rights holder.
- 2. Schedule for the subsequent DPDCL seasons within contractual tenure will be declared at least 01 (One) months before of its commencement.

#### BRANDING BENEFITS AND OTHER DELIVERABLES:

- In addition to the right fees, Rights Holder shall provide price money & trophies as per the directive of BCB i.e. Player of the match price money & Trophy, Player of the Tournament price money & Trophy, Runner Up price money & Trophy and Champions price money & Trophy. Both Party will mutually decide the value of the price monies and the design of the trophies.
- Rights Holder shall have the tournament / league naming rights i.e. Bangabandhu Dhaka Premier Division Cricket League (DPDCL) 2019-20 sponsored by (Rights Holder's Name) only for the season (DPDCL) 2019-20 and rest of the season the naming right would be i.e. (Rights Holder's name) Dhaka Premier Division Cricket League (DPDCL) 2019-20 powered by (other Brand of Rights Holder's Name)
- 3. Event /Tournament/ league Logo shall contains Title Sponsorship and Ground Branding Rights holder logo as per the BCB's Logo policy.
- 4. Every participating team/club jersey/attire must contain official event logo on a designated place as per BCB's Clothing & Equipment Guideline.
- Rights Holder shall enjoy the following benefits for being the Title Sponsorship and Ground Branding Rights holder of Bangabandhu Dhaka Premier Division Cricket League (DPDCL) 2019-20 and subsequent season of DPDCL i.e. season 2020-21 & 2021-22.
- 6. 50 (Fifty) Perimeter Boards (6m X 1m each) (position to be decided by BCB) for Bangabandhu Dhaka Premier Division Cricket League 2019-20 and for subsequent season of DPDCL i.e. season 2020-21 & 2021-22 .Costs related to printing, handling, installation maintenance, removal and dismantle of the boards will be borne by Rights Holder.' Any kind of painting on wall (inside or outside the stadium) is strictly prohibited.
- 7. The drinks trolley if used on the playing field during the drinks break will bear the event logo and other logos/ Brand names provided by Rights Holder. Branding size and space to be determined by the BCB.
- 8. Rights Holder logo prominently displayed on the sight screen. Costs related to printing, handling, installation maintenance, removal and dismantle of the boards will be borne by 'Rights Holder.'
- 9. Rights Holder logo prominently displayed on the stumps. Costs related to printing, handling, installation maintenance, removal and dismantle of the boards will be borne by 'Rights Holder'.





- 10. Rights Holder will be allowed to decorate 2 main gates and the VIP entry gate of the stadium. The decoration may have the sponsor's branding and the event logo. BCB logo will have to be included in the gate decorations (subject to BCB's decision and venue condition/ availability). Costs related to printing, handling, installation maintenance, removal and dismantle of the boards will be borne by 'Rights Holder'.
- 11. Rights Holder will be entitled to the Naming Rights of the two Bowling Ends at each venue (subject to BCB's decision and venue condition/ availability). The two bowling ends will have branding elements of the size 30ft X 5ft. Rights Holder will have to remove the branding at their cost within 2 (Two) days of the conclusion of the League. Costs related to printing, handling, installation maintenance, removal and dismantle of the boards will be borne by 'Rights Holder'
- 12. 'Rights Holder.' will be entitled to display advertisements by branding the Mid-Wicket area. In this case all the 4 (Four) brands/logos/pictures are allowed at the near end side of the wicket from the VIP grand stand. The size of each of the branding will be 20ft X 15ft (300sqft). 'Rights Holder' will be allowed to have multiple branding in a total of 600 sq. ft. area (subject to position the branding within the 30 yard (27.50 meter) circle of Mid-Wicket Pitch Mat Area). For the activation, easily washable and eco-friendly paint must be used directly on the ground. No mats are allowed for this branding purpose at any time. This branding must be approved by BCB prior to its installation. The 'Rights Holder' will have to remove the branding by the Sponsor due to ongoing or any other International Cricket Series to be staged in Bangladesh (especially at SBNCS) during the Bangabandhu Premier Division Cricket League (DPDCL) 2019-20 and subsequent season of DPDCL i.e. season 2020-21 & 2021-22.
- 13. Rights Holder will be entitled to brand the boundary rope by using panels of the size 6 inches X 2 ft. The number of panels will be approximately 700.
- 14. Rights Holder may distribute "Fours" and "Sixes" placards to spectators entering stadium where the Matches are taking place subject to prior BCB approval of the format of the same.
- 15. Rights Holder logo prominently displayed on the backdrop of the prize distribution ceremony podium.
- 16. Rights Holder will provide "Dhaka Premier Division Cricket League Trophy and Medals" (Logo of the Sponsor to appear on the Trophy & Medals).
- 17. The trophies must contain the BCB logo. The trophies will be displayed at the prize distribution ceremony at the final match day. Trophy stand to be provided by the Rights Holder.
- 18. Tournament logo to appear on the Backdrop of the Press Conference.





- 19. Naming rights for Man of the Match, Man of the Series, Highest Wicket Taker, Highest Run Scorer, Champion, Runners-Up and Third Place. All the prize money and prizes/gifts for the awards mentioned above shall be provided by the Rights Holder. All costs related to prize giving ceremony (i.e. Podium, backdrop etc.) shall be borne by the Rights Holder.
- 20. All production cost related to all printing, branding, installation, distribution, pressconference, prize giving programme at hotels/respectable venues etc will be borne by the Rights Holder.
- 21. Only Rights Holder and other logos/ Brand names provided by the Rights Holder shall be entitled to put maximum 20 branded umbrellas in the ground for journalists, police and others.
- 22. A press conference will be held where Rights Holder associations with the tournament only will be announced. Respective representatives from both the organization will be invited to attend the press conference. All costs for the Press Conference will be borne by the sponsor.
- 23. Rights Holder will remove any public expression of this sponsorship in the form of any outdoor advertising at the conclusion of the term of sponsorship.

## INELIGIBILITY: R DIVISIO

- 1. Companies related to Tobacco, Alcohol (surrogated and non-surrogated), Betting, online betting shall not be eligible to participate in the EOI.
- 2. Any person(s) or entities with an existing unresolved dispute with BCB or ICC on a point of law or fact shall be ineligible to acquire the aforementioned rights or to participate in the EOI.

The EOI along with financial offer must be submitted to the BCB Management Office at Sher-e-Bangla National Cricket Stadium, Mirpur-2, Dhaka-1216, Bangladesh by the close of business hours on <u>Saturday 7<sup>th</sup> March, 2020</u> in a sealed envelope addressed to the "Chief Executive Officer, BCB".
